Securing Appointment Date

Your appointment date(s) and service(s) will be secured when the signed contract and deposit have been received. All bookings for weddings are made on a "first-come-first-served" basis. No dates will be guaranteed without a signed contract and deposit. _____

Deposit

All reservations for parties up to 3 people must be reserved and guaranteed with a \$150. deposit. Parties of 5 or more must be reserved and guaranteed with a \$250. deposit. Parties with 8 or more must be reserved with a \$400. deposit. Your day will be secured upon the receipt of your deposit. For on-location weddings, the balance will be charged to the credit card on file the morning of the service, unless other arrangements have been made. Any additional services charged at the end of the day. _____

Payment

Remaining balance is due the day of service. Prices are subject to change as attendants needs change or as services are added or upgraded. Prices do not include gratuity. However, a twenty (20)% service charge will be added to your total services. We accept CASH, CHECK, MASTERCARD, VISA, and DISCOVER as forms of payment. _____

Contract/Appointment Changes

All agreements will be made in writing. The 'Bridal Agreement Terms and Conditions' with the 'Bridal Contract' must be returned to A Signature Day Spa with your deposit. The wedding coordinator will email you a copy of the services and time for any services booked. Any changes or additions to wedding party services after the contract is signed must be submitted by email to: Deannavtnails@yahoo.com or by phone confirmation no later than 7 days prior to the service date. Charges for guests requiring additional services or deleting service must be paid in full on the day of service. _____

Cancellations

Services cancelled thirty (30) days or more prior to date of service will be refunded the deposit amount less twenty (20)%. Any cancellations made with less than seven (7) days notice will be charged the entire cost of the cancelled service(s) and will be placed on the final bill.

*The bride/individual signing this contract may permit only one other person to authorize or submit and change any scheduled service for the wedding party. Deanna McGinness shall act as your wedding coordinator. Any requested changes must be confirmed and acknowledged by Deanna. Cancellations due to emergencies are considered on a case-by-case basis per the wedding coordinator's discretion.

Late Arrivals

If the wedding party is more than thirty (30) minutes late the party will be charged an additional \$15.00 late fee for each guest serviced. Tardiness results in scheduling and service conflicts for you and other clients following your appointment(s). If a wedding party is late for the scheduled service appointment time(s) and notifies us of a new arrival time, stylists may or may not be able to accommodate the new arrival time. If the scope of the original contract cannot be fulfilled due to client's tardiness, services may be reduced; however, clients are liable for the original contracted amount. _____

*If a wedding party is more than one (1) hour late without making contact with us, the assumption is that the client is a no-show. This results in the client forfeiting all deposits and being charged for the full contracted amount. _____

We apologize for any inconvenience but we must follow this policy out of respect for our stylists and other clients.

Wedding Planning Timeline

6 months to perfection

6 months before:

- Meet with wedding coordinator to reserve your wedding day and place deposit.
- Schedule hair and make-up consultation.
- Begin scheduling hair, waxing and nail services every 4-6 weeks.
- Consult with colorist about hair color change or highlights.

Three months before:

- Begin facial treatment program (Series of 6 recommended).

Two months before:

- Confirm all wedding day updo, makeup, manicure and pedicure appointments for you and your bridal party
- Strengthen nails by setting up weekly/biweekly appointments.
- Schedule a pedicure.
- For wedding hair that shines, schedule a Moroccan Oil treatment.

Five weeks before:

- Schedule a bikini or Brazilian wax. Discuss honeymoon waxing.
- Schedule an eyebrow shaping.

Three to four weeks before:

- Finalize all appointment changes to wedding day schedule.
- Schedule trial bridal up-do, remember to bring your headpiece or veil. Please come with clean, dry hair.
- Schedule a trial bridal make-up application. Remember to bring your favorite make-up.
- Purchase any cosmetics you will need for wedding day touch-ups.
- Schedule manicure, pedicure and couples massage for bride and groom.

Two weeks before:

- Enjoy your final facial. Why not add a massage?
- Have your stylist color or highlight your hair for the big day.
- It's time for the guys in the wedding party to get their haircuts!

One week before:

- Have your final eyebrows, legs, underarms and bikini waxed.
- Have eyelash tinting—recommended for wedding criers.
- Meet with your hair stylist for final highlights and hair shaping.

One to two days before:

- Enjoy your manicure, pedicure and couple massage for the bride and groom.
- Enjoy your manicure and pedicure with your bridal party, mother of bride and mother of groom.
- Enjoy time with your bridal party while they get their spa services.
- Please wash hair the day before a wedding day up-do. Natural hair oils help set the style.

- Final hair and make-up appointment for bride, wedding party, and mothers of bride and groom.
- Enjoy your special day!!
